## CYLINDER RENTAL AGREEMENT

CONTAINERS ARE NOT TO BE REFILLED WITH GAS OR ANY OTHER SUBSTANCE WHILE IN CUSTOMER'S POSSESSION. CUSTOMER AGREES TO RETURN TO SELLER IMMEDIATELY ANY CYLINDERS NOT IN USE OR IN THE EVENT CUSTOMER IS NO LONGER DOING BUSINESS.

### ***LOST OR UNRETURNED CYLINDER(S)***

CUSTOMER AGREES TO PAY FOR CYLINDER(S) OR FITTING(S) DAMAGED IN ANY WAY OR LOST WHILE IN CUSTOMER'S POSSESSION. IF CYLINDERS ARE BURNED, VALVES ARE BROKEN, OR ARE DIRTY TO THE EXTENT THAT CLEANING IS REQUIRED, CHARGES FOR REPAIRS/MAINTENANCE WILL BE BILLED TO THE CUSTOMER. CYLINDERS/EQUIPMENT REMAIN THE RESPONSIBILITY OF THE CUSTOMER WHILE IN THE CUSTOMER'S POSSESSION, AND SHALL NOT BE ABANDONED IN ANY FACILITY OR JOB SITE.

ANY CYLINDER NOT RETURNED OR PROPERLY ACCOUNTED FOR WILL BE BILLED AT THE FOLLOWING RATES:
